On January 13, 2022, the U.S. Supreme Court struck down significant portions of OSHA's emergency temporary standard (ETS), requiring businesses with 100 or more employees to ensure workers are either vaccinated against the coronavirus or undergoing weekly COVID tests. At the same time, the Court let stand rules that allow the federal Centers for Medicare & Medicaid Services (CMS) to require COVID-19 vaccination for health care workers at Medicare- and Medicaid-certified providers and suppliers.

What kind of COVID policies should your workplace now have in place?
